     If the Guardian is NOT a Shareholder, a copy of the NIC/Data page of the Passport of the Guardian is MUST.
- Legal Entity Shareholders, MAY submit a copy of the Board Resolution passed by such Legal Entity Shareholder, appointing a person to attend the AGM along with the Proxy Form, which MUST be signed by an authorized signatory.
- If the person representing the Legal Shareholder is also a Shareholder, a copy of the NIC/Data page of the Passport is OPTIONAL.
- If the person representing the Legal Shareholder is NOT a Shareholder, a copy of the NIC/Data page of the Passport is a MUST.

#### Notes

- Eligible Shareholders are requested to pre-register their attendance through Maldives Securities Depository Company Pvt Ltd's ("MSD") online system "Infinity" https://infinity.mv/ or by submitting a "Pre-registration Form" by e-mail to investor.relations@ooredoo.mv or to Ooredoo Maldives Headquarters, Bageechaa Hingun, Hulhumale' 23000, Republic of Maldives, by no later than 20.30 hrs. on Tuesday, 5<sup>th</sup> March 2024.
- Shareholders who have not registered (to attend or to appoint a Proxy) by 20.30 hrs. on Tuesday, 5th March 2024 will not be entitled to participate and vote at the AGM.
- Shareholders under the age of 18 can be represented at the AGM by the Guardian on record with the Company. Guardians who wish to appoint a Proxy to represent the minor Shareholder at the AGM can do so by submitting a Proxy Form.
